

A message from our President

In 1800, when Thomas Jefferson was elected President of the United States, there was a terrible acrimony when he took the Oath of Office. There was note one Republican serving on the federal bench. Jefferson's predecessor, John Adams, had stacked the bench with members of his own Federalist party. This ultimately led to the collision between the judicial branch and executive and legislative branches in Marbury v. Madison three years later. The justices established the essential Rule of Law that Courts were empowered to declare the improper actions of the legislative and executive branches as being unconstitutional—thereby serving as the ultimate check and balance in our democracy.

The same rule of law is being severely tested in our State. I do not think that any other state in our country has the very existence of their court system tied legislatively to the outcome of appellate rulings. After *Gannon* was announced—finding that the school financing formula was unconstitutional under the Kansas Constitution, it was a remarkable scene to have reporters ask our Governor if we still had a court system. Legislatively, the Court system was supposed to lose its funding in the event of this outcome. Apparently, we are still waiting to see as this matter pends on appeal.

We are now just two months away from the start of the next legislative session and it does not appear that the hostilities are going to lessen but only continue as the executive and legislative branches endeavor to change—and politicize—the selection of our appellate judges. This is so disconcerting when our non-partisan selection process has served our State so well for decades. It is almost unimaginable to even think about our appellate judges running statewide for re-election. It is unsavory to consider the role of special interests and money entering our judicial selection process.

While it is clear that all of us have a First Amendment Right to criticize judicial decisions, threats against judges are as irresponsible as threats against any other civil servant. Threats or intimidation of judges is incompatible with the Rule of Law set forth more than 100 years ago by the United States Supreme Court. As lawyers and servants of the law, it is our continuing duty to work to preserve the independence of our judiciary and to defend our Constitution. Make your voices heard!
